- All players are responsible for determining their own draw times.
- Main draw matches will be best 2 out of 3 sets with 12 point tie-break at 6-6 in all sets.
- Consolation entrants must register at draw table after losing first round match. Players who default their first round match may not be allowed into consolations.
- The Tournament Committee reserves the right to alter the format. Events may be modified, combined or cancelled depending on entry.
- Players must be prepared to be called upon to be line judges.
- Proper tennis attire is required, including flat-soled tennis shoes.
- Players who incorrectly enter a rated event will be placed in the proper event. The Wheat City Tennis Committee reserves the right to set a player's rating.
- The Committee/Club will not be responsible for misinformation over the phone.
- Court surface is plexi-pave.
- To minimize scheduling conflicts for the convenience of all players, please make every effort to be available for the assigned draw times. Draw master would appreciate your cooperation.
